## **The Way Forward**

Lambeth Council has published its **Borough plan LAMBETH 2030**, **Our Future**, **Our Lambeth**.

It commits to:

- 1. Get the basics right and deliver great public services that fit what people need.
- 2. Allow people to have a say and stake in the decisions that matter.
- 3. Work together in partnership to harness what makes Lambeth special.
- 4. Ensure that they are accessible, transparent and stand up to challenges.

In the light of these commitments and as residents who will be impacted by the delivery of the plan we need to have an input into making Lambeth a' **Borough of Equity and Justice**' for all. As a pensioners group we need to plan not only to meet the challenges that confront us on a national level, but also the those we come up against on a local level.

David has put forward his suggestion on why and how we should reshape our thinking, objectives and work to become more active and inclusive. (See below)

"Here are my ideas for a future LAMPAG meeting where our members can put forward their ideas on what they want in Lambeth not in 2030 but from now and in the next few years. This is something we can do at meetings during the course of the year. Suggestions we can make into a document and not only present it to Lambeth Council but also have it published in the South London Press and the Brixton Bugle. I feel we should not just concentrate on pensioners matters but include ideas for children, young people, the disabled, those with housing problems etc. in other words we should be inclusive NOT exclusive. Subjects for discussion:

Environment, Health Care, Climate change, Housing, Leisure, Facilities for children, after school clubs and during school holidays, Youth centres where young people help plan and run the activities. More disability access to both public and private places. Use Town Hall for community activities and for all consultations with Lambeth residents of all ages instead of spending large sums of money on renting other places. Regarding council spending, do NOT use private companies to run workshops and meetings. There is a wealth of experience in the community. Utilise their ideas after all they are the residents of Lambeth.

There must be other areas I have not included, so our members need to be included in discussion at a future meeting. After this a small working group should formulate a document into a small booklet.

Lambeth wants to hear from residents about how things are and what would make things better. **We have** the answers. Creating an Age Friendly Lambeth is closely linked to the delivery of the Lambeth 2030 Borough plan We need to have a stake in both.
