### Lambeth Older People's Alliance (LOPA)

LAMPAG members joined a cross section of voluntary groups at a meeting of the relaunch of LOPA. LOPA was re-launched Lambeth in response to Council's proposed cuts to older people's services and funding to older people's centres. These cuts will exacerbate loneliness, social isolation and poor health caused as a result of previous cuts. The cuts have been proposed without consultation and without an equalities impact assessment of the impact of former cuts to older people's services.

Dot Gibson, General Secretary, NPC said that older people face many challenges of pensioner and fuel poverty, social care and health services in crisis. The NPC stands up for today and tomorrow's pensioners. There was a need for intergenerational action against Austerity with younger people who faced similar concerns. We needed to show that working together can be done as has been demonstrated in the LOPA meeting.

John McDonnell MP Shadow Chancellor of the Exchequer said that Austerity has brought absolute and untold misery on whole communities and the Welfare State was being systematically dismantled. Austerity is not working and has been reckless bankers. caused bv the suppression of wages, tax avoidance and evasion. It was a political choice not an economic necessity. The Labour Party stood for investment in a fair taxation People wanted hope and an svstem. alternative understanding of the world. There was an alternative. We had a responsibility to defend the right to live in a civilised society.

The mood of the meeting was that oft disbelief that a Labour Council would cut the very services that people depended upon and that they would neglect of other essential services like heating.

Contributions from the floor raised concerns amongst others of safeguarding adults with mental health problems, unreliable heating on council estates, cuts to library services, the fragmentation of police services and the TTIP proposals that will increase the privatisation of the NHS.

It was clear that the Council is not listening and ignoring the demands of people to share ideas and strategies to

LAMPAG member were seen on the march to Downing Street against the **Housing Bill.** Protesters are angry about proposals to sell off council and housing association homes and introducing two to five year tenancies for transferred and new tenants.

The Bill also proposed local authorities being forced to sell 'High value 'council homes' not fund extending right to buy to Housing Associations. Under the new policy announced at last year's budget, families or an individual earning more that £40,000 a year in London and more than £30, 000 elsewhere will be to pay local tackle them. It was crucial that we got together pooled ideas, strategies and actions to oppose and defeat the cuts for '**United we stand and divided we fall**'. LOPA looks to building the resistance against the Lambeth Council cuts by joining forces and campaigning around the issues.

authority rates rather than lower social rent. The Housing Bill will worsen Britain's shortage of homes. It will condemn ten of thousands of hard working families to leave their council homes and find themselves unable to afford a local alternative.

As pensioners we need to defend people's right to decent affordable social hosing and for older people to live in safe, warm, well insulated homes updated to support independent live in our later years.

### Junior Doctors' Day of Action

Junior doctors in England will take a second day of action after contract talks ended without agreement. They will carry out a 24 hour strike action form 8am Wednesday 10 February to 8am Thursday 11 February. They will provide emergency services.

The Health Secretary, Jeremy Hunt has accused the BMA of behaving in a 'totally irresponsible' way in the ongoing dispute about junior doctors' contracts. In turn the BMA has accused Jeremy Hunt of spreading 'misinformation' about the terms being offered by the government and of fuelling a sense of grievance among its members.

The government is introducing a new contract for junior doctors as part of the drive to put the NHS on a seven day working basis.

Although some of the issues have been realised there is still a dispute about the expectation that doctors will work on Saturdays without receiving premium pay. The BMA claims the Hunt was ignoring the need for the NHS to receive more staff and more funding. Doctors were already working around the clock seven days a week and they do so under existing contracts. If the government wanted more seven day services, they need more doctors, nurses, diagnostic staff and the extra investment needed to deliver it.

Doctors provide an essential service. They are the backbone of the NHS and as service users of hospital services, we need to give them our support. We must defend the Junior Doctor's right to strike for enhanced working conditions. The NHS is buckling under mounting pressure and needs to be protected and preserved. It is our NHS.
